

WHAT ROLE PROGRAMS?

Programs is an important role in the life of a Rotary club. It is often the main way that clubs interact with the broader community and Rotary.

Clubs use the program schedule to facilitate collaboration with community groups. Often community groups will offer guest speakers as a part of their outreach program.

Community groups will often present to a Rotary club and some sort of involvement between the two

organisations develops, other times they do not. The tension for clubs is to allow community groups to speak to the club to broaden our knowledge of service in the community, but not to allow organisations who are simply looking for donations, seeking a market, self-promotion, or even credibility.

Though Rotary is not a political organisation and sees itself as politically agnostic, many worthy community groups take a political stand to benefit the achievement of their community work.

The club recently hosted the "Friends of Westernport" group who are campaigning against the proposed AGL floating gas terminal off Crib Point. By its nature, the campaign has won political support and then becomes political. Does this mean that we should not have had the speaker from Friends of Westernport?

It is common for a Rotary club to invite local politicians as a guest speaker. The Federal member for Flinders and the State member of Mornington have both supported our club in the past. Many clubs within our cluster invite a newly elected local member to speak and build a relationship to further our community interests.

The purpose of Programs is to:

- · educate members
- entertain members
- · sustain club attendance
- · support the club's program to do good in the world
- · improve Rotary knowledge
- · collaborate with other Rotary clubs
- · collaborate with community groups
- collaborate with the club's geographical community

So as Programs Director, my question is: Is there any reason why a request to speak to our club should be denied? If so on what grounds would that denial be and then how should we deal with it? Another question might be: Are we prepared to expose ourselves to views that we may not have considered, or that we pre-judge as inappropriate content?

If we decided that there are no grounds upon which we deny a potential speaker, should we have a set of guidelines given to speakers, and what would those guidelines contain?

If you have a view on the three questions above, please let me know your thoughts, I will take submissions up to Dec 31^{st} and produce a summary for the club

COVID Safe Summer From 11.59pm, 6 December 2020, unless otherwise stated

The following are the main points announced today by the Victorian Government. Full details can be found on the website https://www.dhhs.vic.gov.au/coronavirus

Face Masks:

Face masks: Must be carried at all times. Mandatory when inside shopping centres, retail stores inside shopping centres, department stores, electronics stores, furniture stores, hardware stores or supermarkets, when travelling on public transport or when travelling in a commercial passenger vehicle (unless a lawful exemption applies). Face coverings are recommended, but not mandatory, when leaving home and physical distancing cannot be maintained, for example, while shopping.

Eating and drinking out

Hospitality: Density quotient of 1 per 2sqm for indoor and outdoor hospitality venues. Up to 25 patrons are permitted in a venue before the density quotient applies. No requirement for seated service. Density quotient of 1 per 4sqm on a dancefloor up to a maximum of 50 people. All venues are required to use electronic record keeping when applying the density quotient of 1 per 2 sqm. In venues not using electronic record a density quotient of 1 per 4 sqm applies.

Exercise and recreation

Indoor physical recreation and community sport: No patron caps with a density quotient of 1 per 4sqm for each space. Gym and exercise classes limited to 50 people (excluding anyone necessary for running the class). COVID Marshals required when gyms are staffed. At times when gyms are unstaffed, a density quotient of 1 per 8 sqm applies. Signage must state the number of people permitted inside, wipes and disinfectant must be supplied for use by patrons, and record keeping is required and venues with capacity of greater than 500 patrons must publish a COVIDSafe Plan online.

Outdoor physical recreation and community sport: Up to a maximum of 100 patrons for outdoor fitness classes with a density quotient of 1 per 2sqm. Record keeping is required and venues with capacity of greater than 500 patrons must publish a COVIDSafe Plan online.

Pools, spas, saunas, steam rooms and springs: Indoor venues open with a density quotient of 1 per 4 sqm. Outdoor pools open with a density quotient of 1 per 2 sqm. Record keeping is required

Ceremonies and special occasions

Weddings: No maximum attendee caps indoors or outdoors, density quotient of 1 per 2 sqm applies when using electronic record keeping. In venues not using electronic record a density quotient of 1 per 4 sqm applies. If held in a private residence, up to 30 guests can attend. Density quotient of 1 per 4 sqm on a dancefloor up to a maximum of 50 people

Funerals: No maximum attendee caps indoors or outdoors, density quotient of 1 per 2sqm applies when using electronic record keeping. In venues not using electronic record a density quotient of 1 per 4 sqm applies. If held in a private residence, up to 30 guests can attend.

Entertainment facilities

Seated entertainment venues (indoors and outdoors): Open, up to 75 per cent of fixed seated capacity with maximum patron cap of 1000 people, density quotient of 1 per 2sqm in foyers, bars, bathrooms etc when using electronic record keeping. In venues not using electronic record a density quotient of 1 per 4 sqm applies. Venues with capacity of greater than 500 patrons must publish a COVIDSafe Plan online. Arrangements for large events determined on an individual basis under the Public Events Framework. Indoor non-seated venues (such as galleries): Open, up to 50 per cent total capacity with maximum patron cap of 1000 people. Density quotient of 1 per 2sqm when using electronic record keeping. In venues not using electronic record a density quotient of 1 per 4 sqm applies. Venues with capacity of greater than 500 patrons must publish a COVIDSafe Plan online. Arrangements for large events determined on an individual basis under the Public Events Framework
